Queens Civic Congress urges its members to speak out against the MTA hikes and mobilize their members to do the same. The Queens hearing takes place January 20 (details below). The proposals present a particular hardship for Access-A-Ride users. As to financing, Queens Civic Congress recommended proposals during the "discussions" over whether to impose a concession tax; today toll taxes imposed on our free East River and Harlem River crossing seem to be the latest attempt to exploit our pockets.
